Phoenix Apartments is an 83-unit affordable housing community in Providence, Rhode Island's vibrant West End neighborhood. The scattered-site community consists of 27 walk-up buildings distributed around Cranston Street, the neighborhood's central artery. Phoenix Apartments is restricted to households earning at or below 60% of the area median income (AMI) and is home to 200 residents who enjoy amenities, including a community room, on-site laundry, and access to public transportation.

Woodland Homes, located in Lexington, Tenn., has provided seniors aged 62 and older with affordable, low-income housing since 1981 as a Department of Housing and Urban Development Section 202/8 property and recently as a 202/8 and Low-Income Tax Housing Credit property. The multiplex retirement community has 61 units and includes an on-site care manager, a variety of amenities and educational and entertainment programs.

Entrants are judged on how they manage their properties' physical, financial, and social conditions and how well they convey their success in offering their residents the highest quality of life.

The 2024 COQ Awards will be presented as part of a special luncheon and panel discussion with the winners on March 20 during the NAHMA's Biannual Top Issues in Affordable Housing <u>March</u> <u>conference</u> on March 19-21.
