### 2024 NAHMA Scholars


The NAHMA Educational Foundation selected 118 student residents to receive scholarships in 2024. Each scholarship was worth \$3,500; the total amount of scholarship money awarded was \$413,000. Additionally, \$2,000 was donated to the Department of Apparel, Housing and Resource Management at Virginia Tech for scholarships for students pursuing their bachelor's degree in property management. This year's class of NAHMA Scholars came from 20 different states and they represent 13 different regional Affordable Housing Management Associations (AHMAs). 




