The multiday meeting, taking place March 19-21 in Washington, D.C., will highlight panels concentrating on affordable housing practitioners' issues and educational topics for navigating today's world led by experts in their fields. The annual meeting features several educational panels geared explicitly toward the affordable housing industry. Bob Simpson, the president of the Multifamily Impact Council, will provide the keynote address. Invited guests include representatives from the Housing and Urban Development and Agriculture departments and more. Panels containing government officials and other special guests are not open to the media and may not be recorded. Event registration includes admission to all sessions and open committee meetings, the Communities of Quality Awards luncheon and panel discussion, and the Industry Awards ceremony.
